**ACTION REQUESTED**

That your Board approves the attached resolution permitting designated County Staff to execute for and on behalf of the County for all actions necessary to obtain funds from the 2006 Homeland Security Grant Program.

**BACKGROUND**

Placer County is subgrantee of the State of California for numerous grant programs including the Homeland Security Grant Program (HSGP) and the Law Enforcement Terrorism Prevention Program (LETPP), both of which are managed by the Governor's Office of Homeland Security (OHS) under the single Homeland Security Grant Program.

Federal grant programs require local governing Boards (i.e., your Board) approve a resolution appointing specified staff to execute for and on behalf of the County for all actions related to their grant programs. Through this resolution, your Board specifically authorizes designated staff to approve applications from OHS (and others) and to request reimbursement of any grants approved. *For Federal Fiscal Year 2006 grants, OHS requires a new Governing Body Resolution.*

Based on position and staff responsibilities in the areas of homeland security, fire prevention, and law enforcement grants management, the below listed individuals are the most appropriate to execute for and on behalf of the County, and their authorization shall be valid for a term of five years from the date of the fully executed Resolution:
