BACKGROUND

The purpose of the Placer Sierra Fire Safe Council is to evaluate the high fire threat for the PSFSC planning area including the City of Colfax and the unincorporated area surrounding it up to Secret Town and the Placer Hills Fire District, covering the communities of Meadow Vista, Weimar, Applegate, Clipper Gap and Eden Valley. The committee is comprised of seven core members and each member must reside in or own a business within the PSFSC planning area. After the initial terms of appointment have expired, each subsequent appointment will be for two-year terms.
