SUBJECT: **ABANDONMENT AND RELOCATION OF A PORTION OF AN  
EMERGENCY ACCESS EASEMENT – SILLER RANCH.**

## **ACTION REQUESTED / RECOMMENDATION**

Adopt a Resolution to abandon a portion of an Emergency Access Easement.

## **BACKGROUND / SUMMARY**

In 2004, an Emergency Access Easement was dedicated to the County through the Siller Ranch property to Northstar, recorded as a separate document in Series 2004-0175762. A portion of the easement provides that the parties will take actions necessary to relocate the easement to conform to subdivision roadways as they are mapped and accepted by the County.

The 2004 easement passes through a portion of Siller Ranch recently subdivided and known as Martis Camp Unit No 1, recorded in 2005 in Book BB of Maps at Page 17. The 2004 easement has been replaced by the roadways depicted on this subdivision map, specifically Schaffer Mill Road, and therefore, there is no longer a need for emergency vehicles to rely on the 2004 easement.

All processing fees have been paid, the proposed easement abandonment has been distributed for comment and no objections have been received. The proposed abandonment qualifies for Summary Vacation and therefore, does not require posting or scheduling of a separate public hearing.

## **ENVIRONMENTAL CLEARANCE**

This action is categorically exempt from the provisions of CEQA Class 5 (Guideline 15305), minor alterations to land use limitations.

## **FISCAL IMPACT**

Fair market value for the easement proposed for abandonment is offset by the alternate easement already dedicated. Therefore, there is no fiscal impact anticipated to result from this action.

### LEGAL DESCRIPTION ABANDONMENT OF PORTION OF 25' EMERGENCY ACCESS EASEMENT, DOC. NO. 2004-0175762 O.R.P.C.

The land described herein is situated in the County of Placer, State of California, and described as follows:

A portion of Section 26, Township 17 North, Range 16 East, M.D.B.&M., also being a portion of the plat of "MARTIS CAMP UNIT NO. 1", filed for record in the office of the Recorder of Placer County in Book BB of Maps, Page 17, also being a portion of that certain emergency access easement to the County of Placer, filed for record in the office of the Recorder of Placer County in Document No. 2004-0175762 more particularly described as follows:

A strip of land, 25 feet in width, the centerline being described as follows:
