**SUBJECT:** Authorize the Sheriff to accept the grant and execute the contract with the Department of Alcoholic Beverage Control and Office of Traffic Safety for the Minor Decoy Program

**ACTION REQUESTED**

Your Board's approval is requested to authorize the Sheriff to accept the grant in the amount of \$20,000 and execute the contract for the Minor Decoy Program from the Department of Alcoholic Beverage Control (ABC) and Office of Traffic Safety (OTS). Your Board's approval of the attached budget revision to the Final Budget appropriating these funds is also requested.

**BACKGROUND**

The Placer County Sheriff (PCSO) had submitted a grant request to ABC and OTS to provide augmentation to conduct Minor Decoy operations. This grant provides funding 360 hours of time spent for conducting the decoy operations and surveillance plus \$1,500 for a Preliminary Alcohol Screening (PAS) device and travel costs. The grant scope of work includes nine operations over the course of a twenty-two month time period. The grant targets employees of retail stores who may furnish or sell alcoholic beverages to underage operators. The goal of the grant is to reduce underage drinking and the resultant DUI driving injuries and fatalities, property damage, reduce youth access to alcoholic beverages through enforcement intervention. Your Board's authorization for the Sheriff to accept the grant and execute the contract with ABC and OTS is required.

**FISCAL IMPACT**

There is no net impact to the budget. The grant amount of \$20,000 over a twenty-two month period will be offset by grant revenues. We are currently not sure of how many operations will be done this year versus next. We are requesting this grant be added to the Final Budget. Any funds not expended would be carried over to next year.
