The Council shall also comply with any rules, regulations, and procedures contained in the MAC Manual proscribed and approved by the Board of Supervisors. In absence of procedures to the contrary, the council shall be governed by Robert's Rules of Order. The Council shall keep all record of its actions in a form prescribed by the Placer County Auditor.

COMMITTEE COMPOSITION: Five (5) members, appointed by the Board of Supervisors. Members shall own real property within the area, or own or operate a business within the area. Terms shall be for two years.

COMPENSATION: All members of the Council shall serve without compensation.
