## **ACTION REQUESTED / RECOMMENDATION**

Adopt a Resolution authorizing the Director of Public Works to execute the reimbursement agreement with the Federal Highway Administration for the storm damage to Foresthill Road including the Foresthill Road Slide Repair Project in an amount of \$3,230,000.

## **BACKGROUND / SUMMARY**

Foresthill Road had two major embankment failures this last spring and several minor areas of damage. The Department worked under an expedited schedule to repair this damage prior to this winter. The County proceeded forward with the work using County Road Fund and applied for emergency funding from the Federal Highway Administration (FHWA).

FHWA has reviewed our application for emergency funding and has drafted a reimbursement agreement that is currently estimated at \$3,230,000 for the work to be performed. Final costs are still being determined during the project closeout process.

## **ENVIRONMENTAL**

This project was an emergency repair and public safety project that is exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15301 – Class 1(d). A Notice of Exemption was filed with the County Records Office.

## **FISCAL IMPACT**

The total cost of the project is currently estimated at \$3,280,000. This reimbursement agreement is anticipated to pay for \$3,230,000 of the costs and would reimburse the County Road Funds utilized in both the FY 2005/2006 and FY 2006/2007 budgets.

Repairs to Foresthill Road, Forest Highway 124, for damage caused by CA2006-1-FS disaster event to four sites.  
 Site 1 - FH-124-2006-01 for \$ 25,606 to reshape 125' section of failed cut bank, material disposal, and slope revegetation.,  
 Site 2 - FH-124-2006-02a for \$2,169,564 to excavate and rebuild of failed road section with new underdrain system.  
 Site 3 - FH-124-2006-02b for \$1,002,587 to excavate and rebuild of failed road section with new underdrain system.  
 Site 4 - FH-124-2006-04 for \$ 31,684 to remove and replace 48" x 80' culvert with end sections. Rebuild road bed.
