ACTION REQUESTED / RECOMMENDATION

Adopt a resolution accepting the subject project as complete and approving and authorizing the Director of Public Works to execute the Notice of Completion.

BACKGROUND

The Board awarded Construction Contract No. 73173 to C.C. Myers, Inc. Inc. on April 20, 2006 and authorized the Director of Public Works to execute the contract. Work on this contract was complete on October 3, 2006. The purpose of this project was to replace the existing bridge, which was deteriorating and did not meet current design standards. The replacement bridge and improved approaches brought this bridge into compliance with current structural, geometric, and hydraulic guidelines.

ENVIRONMENTAL CLEARANCE

A mitigated negative declaration was prepared in accordance with the California Environmental Quality Act (CEQA) for this project and was approved by your Board on December 2, 2003. A Notice of Determination was also completed for this project. Environmental Clearance has also been obtained through the Federal NEPA process.

FISCAL IMPACT

The construction contract was awarded for \$705,351.50 with a contingency of \$105,802.73 for a total encumbrance of \$811,154.23. The Department has determined a final estimated construction cost of \$727,154.24 for this project. There were 6 Contract Change Orders (C.C.O.) issued during this project amounting to \$27,323.01. Contract data and C.C.O. summaries are attached as Exhibit "A". The project was completed under the Federal Highway Bridge Rehabilitation and Replacement Program (HBRR).


