In addition, Linda has played several sports in Lincoln, softball, golf and basketball and coached several seasons for the Lincoln High School Varsity girl's softball team. Linda retired from her position as the Lincoln City Clerk on December 12, 2006 in preparation for her new role as an elected City Council Member. In the matter of a Commendation honoring Linda Stackpoole for her contributions to the City of Lincoln as both lifelong resident of the City of Lincoln and City Clerk for over 22 years.

Whereas, Linda Stackpoole reflects the heritage of her family and their involvement in the heartbeat of Lincoln for three generations; and

Whereas, Linda has lived in Lincoln her entire life on the east side of town close to her family's grocery store that has served the Lincoln community and ranchers from the rural Lincoln area for many years; and

Whereas, Linda first took office in May of 1984 after winning her first election, which was prompted by her dissatisfaction with the customer service provided in the City Clerk's office at the time; and

Whereas, Linda's personal connection with past and present civic leaders has proven invaluable in building her successful relationships with staff, city officials and the public throughout her career; and

Whereas, during her tenure as City Clerk, Linda experienced eleven elections, one recall election, and worked with four City Managers and two interim City Managers in four City Halls; and

Whereas, Linda was also a prominent athlete in the Lincoln area playing softball, golf and basketball holding the record for highest points scored at Sierra College until her record was broken in 1999 with a single game record of 49 points; and

Whereas, in addition to playing sports herself, Linda has enjoyed many seasons of coaching girls softball and assisted teaching Physical Education at Lincoln High School and coaching the Lincoln High School Varsity girl's softball team; and

Whereas, Linda has also volunteered her time to be involved with several community organizations including the Lincoln Rotary Club and the Duane Perkins Foundation and has participated in many "Make a Difference" community clean up days sponsored by the Lincoln Volunteer Center; and

Whereas, Linda has proudly taken her newly elected seat on the City Council having won the November, 2006 election and prompting her retirement from her City Clerk position on December 12, 2006; and

Whereas, of all her accomplishments and contributions to the Lincoln community, Linda's most proud recognition was a tribute bestowed upon her mother, Eleanor Carnesecca, when it was announced at Linda's last day as City Clerk, through the unanimous vote of the park naming committee, that the new Foskett Ranch Regional Park softball complex would be named the "Eleanor Carnesecca Softball Complex" in honor of the many years of selfless contribution her mother made to the girl's softball league. Linda's mother organized the girl's softball league (Young American Girls Softball - YAGS) in the mid -60's. In addition, she stored the equipment in her garage and carried it across the street to McBean Park for games and practices, taught the girls how to play and provided a positive sports experience for Lincoln girls who otherwise might not have had an opportunity to play. Linda has carried forward her mother's passion for softball and the value of community involvement through her own contributions.

**NOW, THEREFORE LET IT BE KNOWN THAT**, on this day February 20, 2007 the Placer County Board of Supervisors does hereby honor Linda Stackpoole for her commitment to community involvement and her willingness to address community issues and congratulates her on her long and successful career as the City Clerk for Lincoln while wishing her continued success as a Lincoln City Council Member.
