SUBJECT: HIGHWAY 49 DIAL-A-RIDE CONTRACT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Chairman to execute Contract Amendment No. 1 with PRIDE Industries for a one-year extension in the amount of \$244,434 to operate Highway 49 Dial-A-Ride.

BACKGROUND / SUMMARY

The Highway 49 Dial-A-Ride provides demand response transit service in the Highway 49 corridor between Dry Creek Road and downtown Auburn. The service area is three quarters of a mile on both sides of the Placer County Transit fixed route. The Highway 49 Dial-A-Ride meets the paratransit requirements of the Americans with Disabilities Act.

PRIDE Industries operates the Highway 49 Dial-A-Ride under contract with Placer County. The current contract is a three-year contract that expires on June 30, 2007. The contract has a provision for two, one-year extensions through June 30, 2009. The proposed contract charge from PRIDE Industries for FY 2007/08 is \$244,434, a 4.8% increase over the current fiscal year. All other contract provisions will remain the same as the original contract.

ENVIRONMENTAL

The project is statutorily exempt from CEQA pursuant to section 21080(b)(10), as it is a project to provide passenger service.

FISCAL IMPACT

The \$244,434 cost of the Highway 49 Dial-A-Ride Contract for FY 2007/08 is included in the proposed Placer County Transit budget for FY 2007/08 and will be funded by Transportation Development Act funds.
