SUBJECT: TART SUMMER TRANSIT SERVICES CONTRACT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Chairman to execute Contract Amendment No. 1 with Airport Mini-Bus for an extension through Summer of 2007 to provide bus drivers for Tahoe Regional Transit (TART) summer transit service in an amount not to exceed \$91,700.

BACKGROUND / SUMMARY

TART operates additional transit service with trolleys and buses each summer. The service provides more frequent service and night time service that is not available during the rest of the year. The TART Summer program is funded by the North Lake Tahoe Resort Association with the goal of providing increased transit service during the peak tourism season.

Each year, TART has difficulty fully staffing the program with additional temporary bus drivers. To address this issue, DPW awarded a contract to Airport Mini-Bus in 2006 to provide qualified drivers to operate a portion of the summer transit program. Airport Mini Bus of Reno, which was the only company to submit a proposal last year, performed well in summer of 2007 and has agreed to extend the contract to summer of 2007. Through this contract Airport Mini-Bus will provide drivers for three of seven additional shifts each day.

ENVIRONMENTAL

This project is statutorily exempt from CEQA pursuant to Public Resources Code 21080(b)(10), as it is a project to provide passenger service.

FISCAL IMPACT

The maximum cost of the contract is \$91,700. TART will be reimbursed by the North Lake Tahoe Resort Association. The appropriation for this contract is included in the proposed 2007/08 DPW Budget.
