**ACTION REQUESTED:**

It is requested that your Board approve the following reappointment and new appointment to the Civil Service Commission:

- Reappoint Mr. Ronald LeDoux at the request of the District 2 Supervisor; and,
- Appoint Mr. Donald J. Nelson at the request of the District 5 Supervisor, effective August 14, 2007.

**BACKGROUND:**

The Placer County Civil Service Commission was created by the voters in 1961. The commission consists of five members appointed by the Board of Supervisors for four-years terms, tasked with the handling of personnel matters. A majority vote of the entire Board of Supervisors is required to appoint a member to the commission. By previous practice, individual Board members provide nominations for approval by the full Board.

Currently, two terms of existing commissioners are expiring. The term of existing commissioner, Mr. Ronald LeDoux expires on August 12, 2007 and he is being nominated for reappointment by Supervisor Weygandt. The term of existing commissioner Mr. Alan Shuttleworth expires on August 14, 2007, and Mr. Donald J. Nelson is being nominated as a replacement by Supervisor Kranz.
