**BACKGROUND**

The Placer County Child Care Local Planning Council is composed of twenty members with representatives appointed from both Placer County and the County Superintendent of Schools consisting of two representatives in each of the following categories: Consumers, Child Care Providers, Public Agency, Community Representatives and Discretionary Members. Seats one thru ten are County appointments and seats eleven thru twenty are Superintendent of Schools appointments. Terms of members shall be three years after their initial appointment. The committee meets on the third Wednesday of every even month. The presiding officer, as needed, may schedule additional meetings, including public meetings.


