**BACKGROUND**

The purpose of the CSA 28, Zone 165 Dry Creek Area Fire Service Community Advisory Committee is to provide the forum by which local public protection issues can be voiced, deliberated and implemented. To work in conjunction with the West Placer Municipal Advisory Council to advise the Board of Supervisors on issues relating to public health, safety, law enforcement and recreation as it relates to emergency and fire issues. The committee is composed of seven members representative of the demographic composition of Zone 28. All members shall serve a two year term.
