SUBJECT: Authorize the Registrar of Voters to Render Election Services for the Los Rios Community College District Bond Election to be held November 4, 2008.

Recommendation

Approve the attached resolution authorizing the County Clerk to render election services for the Los Rios Community College District for a bond election to be held November 4, 2008.

Background

Election Code Section 10002 and Education Code Section 5303 provide that the governing body of any school district may by resolution request the Board of Supervisors to conduct their elections and permit the County Clerk to render necessary election services to the district on a reimbursable basis.

The Los Rios Community College District on July 16, 2008, adopted a resolution by their governing board, requesting the Placer County Clerk to conduct a Bond Election, for that portion of the District within Placer County, to be consolidated with the November 4, 2008 Presidential General Election.

In order for the Placer County Clerk to perform the election functions requested by the Los Rios Community College District, pursuant to Election Code Section 10002 and Education Code Section 5303, the County Clerk must have the approval of your Board.

Fiscal Impact

No net increase in costs to the General Fund. The Los Rios Community College District will pay for this special election based on the approved fee schedule for election services plus reimbursement for any additional, specifically incurred costs.
