SUBJECT: STATE ROUTE 65 / SUNSET BOULEVARD INTERCHANGE PROJECT –
FREEWAY MAINTENANCE AGREEMENT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Chairman of the Board to execute the Freeway Maintenance Agreement for the State Route 65/Sunset Boulevard Interchange between California Department of Transportation (Caltrans) and Placer County.

BACKGROUND / SUMMARY

The Department of Public Works (DPW) is proposing to replace the current at-grade signalized intersection with a grade-separated partial cloverleaf interchange with a six lane over-crossing at Sunset Blvd and State Route 65, the project will reduce traffic congestion, accidents and delays. The project will allow for the future expansion of State Route 65 to eight lanes with auxiliary lanes and will accommodate the increased traffic demand generated by existing and approved development in the project area of south Placer County.

This maintenance agreement will provide the framework to determine the future maintenance responsibility for the proposed interchange and clarifies the areas that are the responsibility of the County and those that are the responsibility of the Caltrans.

ENVIRONMENTAL

The Placer County Board of Supervisors approved the Mitigated Negative Declaration for this project and a Notice of Determination was filed on May 23, 2006

FISCAL IMPACT

The County of Placer will be responsible for the regular maintenance of the roadway, striping, electrical service and other miscellaneous maintenance associated with the area identified in the Freeway Maintenance Agreement. The funding for this maintenance work will come from the Department of Public Works Road Maintenance Budget.
