SUBJECT: RIGHT-OF-WAY CONTRACT, GRANT DEED AND TEMPORARY
CONSTRUCTION EASEMENT FROM KOBRA PROPERTIES –
SUNSET / 65 INTERCHANGE PROJECT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution approving the Right-of-Way Contract and accept the Grant Deed and Temporary Construction Easement from Kobra Properties in the amount of \$74,203 for the Sunset / 65 Interchange Project.

BACKGROUND / SUMMARY

The Sunset / 65 Interchange Project, located on Sunset Boulevard and Highway 65, west and adjacent to the City of Rocklin, will replace the existing at-grade intersection with a grade-separated partial cloverleaf interchange with a six lane over-crossing. Right-of-Way for the project is required from four property owners, one of which is Kobra Properties. The project design requires permanent right-of-way and a temporary construction easement (TCE) from the Kobra parcel. A negotiated settlement with this property owner has been reached which includes 0.106 acres in fee title and 0.055 acres in temporary construction easement.

ENVIRONMENTAL CLEARANCE

The Placer County BOS approved the Mitigated Negative Declaration for this project and a Notice of Determination was filed on May 23, 2006.

FISCAL IMPACT

Construction and Right-of-Way Acquisition costs are funded by County Traffic Impact Fees and the Highway 65 Joint Powers Authority Impact Fees.


