**ACTION REQUESTED**

Present a Resolution commending Cindy Harmon for more than 27 years as a Placer County employee with the Health and Human Services Department.

**BACKGROUND/COMMUNITY BENEFITS**

Cindy began her career with Placer County Health and Human Services on October 14, 1980. Her first position with the department was a Telephone Operator/Receptionist. She worked in this capacity until 1981, when she was promoted to Eligibility Worker. In this position, Cindy determined eligibility for nearly every public assistance program, as well as act as "floater" and quality control worker. In 1993, she was promoted to the position of Eligibility Supervisor. In this capacity, she supervised workers in the AFDC (CalWORKs), Food Stamps, General Relief, and Medi-Cal programs. In 1999, Cindy was promoted to the position of Client Services Section Supervisor, where she supervised employment services case managers. In 2001, Cindy was then promoted to Client Services Program Supervisor, and held this position continuously until her retirement.

Throughout her 27-year history with the County, Cindy has shown herself to be a loyal and dedicated employee and an advocate for the clients and families she helped to serve.
