**ACTION REQUESTED**

Approve the award of competitive Bid No. 9868 to Future Ford of Roseville, CA for one full-size, ¾ ton, 4x4 pickup with tow package and one 4x4 sport utility vehicle with tow package in the total aggregate amount of \$61,243.06, and authorize the Purchasing Manager to sign the resulting Purchase Orders (POs).

**BACKGROUND**

On behalf of Placer County Fire, the Procurement Services Division solicited bids for the department's vehicle requirements. Seventeen vendors were notified electronically of Invitation for Bid No. 9868 which was also posted on the County's website. The Bid stated that the County intends to purchase two vehicles in accordance with the Bid's specifications. One responsive Bid was received from Future Ford of Roseville, CA.

Bid evaluation was based on the lowest vehicle unit price, 75,000 mile bumper to bumper warranty cost, local vendor's preference, and early payment discount. Future Ford is a registered Placer County local vendor. Based on their complete responsiveness to the bid and their favorable pricing, staff recommends approval to award the resulting PO to Future Ford for one 2009 Ford Super Duty F250 4x4 crew cab pickup with tow package in the amount of \$29,266.82 and one 2009 Ford Expedition 4x4 with tow package in the amount of \$31,976.24.

**FISCAL IMPACT**

The POs resulting from this recommendation will total \$61,243.06. County Executive Office's Fiscal Impact Statements are attached.


