**ACTION REQUESTED:**

The Planning Department, on behalf of the Planning Commission, requests the appointment of Planning Commissioner, Ken Denio, to Seat 13 of the Wastewater Advisory Committee for a two-year term.

**BACKGROUND:**

The Wastewater Advisory Committee makes recommendations to the Environmental Health Director regarding ordinance adoption/revisions, review methods, techniques and materials for on-site sewage treatment and disposal, and policy issues.

The Committee is composed of 13 members. Seat 13 is to be held by a Planning Commissioner or Member of the Board of Supervisors for a two-year term.

At its February 26, 2009 hearing, the Placer County Planning Commission unanimously adopted a motion to recommend the appointment of Ken Denio to the Wastewater Advisory Committee.
