SUBJECT: State Contract for Pesticide Application Reporting for Fiscal Year 2009-2010

ACTION REQUESTED

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #09-C0028 with the State Department of Pesticide Regulation for reimbursement up to a maximum of \$7,632 for Pesticide Application Reporting.

BACKGROUND

The California Department of Pesticide Regulation (DPR) provides reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

Under this contract, the County will be reimbursed up to a maximum of \$7,632 for processing and data entering pesticide use reports in accordance with State requirements.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This contract represents \$7632 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 09/10 Agricultural Commissioner's Budget.
