SUBJECT: **PLACER UNION HIGH SCHOOL DISTRICT REIMBURSEMENT AGREEMENT**

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Director of Public Works to sign a Reimbursement Agreement between Placer County and Placer Union High School District (PUHSD) for improvements on Richardson Drive that fronts Chana High School. The County has agreed to share in the cost of the installation by contributing \$7,000 from the Road Fund.

BACKGROUND / SUMMARY

Chana High School is a continuation high school that is located on the west side of Richardson Drive approximately half-way between Park Drive and Dry Creek Road. The main parking lot for the high school is also located on the west side of Richardson Drive, but mainly serves faculty and staff. A parking lot exists on the east side of Richardson Drive, just opposite of the high school, for students to park. Hence, a majority of students have to cross Richardson Drive to get to class.

The Department of Public Works has received requests to paint a crosswalk across Richardson Drive for students to use in order to more easily get from the east parking lot to the high school. In order for this to be accomplished, the American Disabilities Act (ADA) requires that access for disabled individuals be provided in the form of curb ramps. The County has agreed to share in the cost of the installation of curb ramps with Placer Union High School District and Auburn Recreation District.

The estimated cost of the improvements is \$12,000 and the County has proposed to contribute \$7,000.

ENVIRONMENTAL

This action is exempt from CEQA pursuant to CEQA Guidelines section 15301, minor alteration to existing facilities.

FISCAL IMPACT

The County will pay \$7,000 out of the Road Fund.
