

### ACTION REQUESTED

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #09-0518 with the California Department of Food and Agriculture allowing for reimbursement from the State for up to \$8,661 for High Risk Pest Exclusion Program

### BACKGROUND

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs

### ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA)

### FISCAL IMPACT

This contract represents \$8,611 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 09/10 Agricultural Commissioner's Budget
