ACTION REQUESTED

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #10–C0028 with the California Department of Pesticide Regulation for reimbursement up to a maximum of \$7,768 for Pesticide Application Reporting.

BACKGROUND

The California Department of Pesticide Regulation (DPR) provides reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

Under this contract, the County will be reimbursed up to a maximum of \$7,768 for processing and data entering pesticide use reports in accordance with State requirements.

The Agriculture Department receives up to 400 pesticide use reports each month, which must be individually data entered into an electronic file, and transferred to the California Department of Pesticide Regulation.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This contract represents \$7,768 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 10/11 Agricultural Commissioner's Budget.
