**Subject:** U.S. Forest Service Contract Addendum for Law Enforcement Services

**ACTION REQUESTED**

Your Board's approval is requested for the addendum to the annual contracts for FY 2010/2011 operating plans between the Sheriff's Department and the U.S. Forest Service. Modification 010 to the FY 2010 Financial and Operating Plan for Controlled Substance is for an increase of \$20,000, for a total FY 2010 Forest Service agreement of \$45,000. Your Board's approval for the Chairman to sign and to authorize the Sheriff-Coroner-Marshal to execute the agreements and for the Budget Revision to reflect the increase revenues and expenditures anticipated. There is no impact to the General Fund.

**BACKGROUND**

The Sheriff's Department has been contracting annually with the U.S. Forest Service to provide controlled substance enforcement (narcotics investigations) in the Tahoe and El Dorado National Forests. On February 23rd your Board approved the annual operating plan for the Forest Service for both campground patrol and controlled substances in the amount of \$47,000. The update for controlled substances was in the amount not-to-exceed \$25,000. The Federal government received additional funding for Controlled Substance Operations for FY 2010. The increased allocation for our contract is \$20,000 for a revised annual plan for controlled substances for this year of \$45,000.

Your Board's approval for the updated plan agreement is required for both fiscal years, for the Sheriff to execute the updated agreements and for the budget revision to reflect the anticipated increase of revenues and expenditures.

**FISCAL IMPACT**

The amendment for the FY 2010 plan will provide an additional \$20,000 of services available to the Forest Service through this contract period ending September 30, 2010. There is no impact to the General Fund.

Except as cited herein, all other forms and conditions of this Cooperative Agreement between Placer County Sheriff's Office and U.S. Forest Service, remain the same.
