## ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the execution of the 2010/2011 State Transit Assistance Claim for Placer County Transit in the amount of \$644,702.

## BACKGROUND / SUMMARY

Annually, the Placer County Transportation Planning Agency (PCTPA) notifies Placer County of the amount of the State Transit Assistance (STA) funds available for allocation in the Lake Tahoe region. In Fiscal Year 2009/10 this funding source was suspended by the State. In March, 2010 the Governor signed into law ABx86 and ABx89 which restored funding to the STA fund. PCTPA is responsible for regional planning and allocation of these transportation funds in Placer County outside of the Tahoe Basin. The County has been informed that amount of funds available of \$644,702 is intended to cover a two period of FY09/10 and FY10/11.

In order for Placer County to receive the funds, it is necessary for your Board to execute a claim requesting the STA funds. Attached for your review and action is a State Transit Assistance Claim in the amount of \$644,702 for submittal to the Placer County Transportation Planning Agency on behalf of Placer County Transit and Tahoe Area Regional Transit.

## ENVIRONMENTAL

The proposed action is not a project as defined by Public Resources Code Section 21065 and is therefore exempt from environmental review under CEQA.

## FISCAL IMPACT

The funds will be used for operations by Placer County Transit and will be budgeted in the Final 2010/11 Fiscal Year Budgets.
