

SUBJECT: Citrus Research Board funding for Asian Citrus Psyllid detection trapping
April 15, 2010 through June 30, 2010.

ACTION REQUESTED

Adopt a resolution authorizing the Placer County Agricultural Commissioner/Sealer to sign a Memorandum of Understanding with the Citrus Research Board allowing for reimbursement for up to \$3,963 for costs associated with detection trapping of the Asian Citrus Psyllid in Placer County from April 15, 2010 through June 30, 2010.

BACKGROUND

This contract will provide funding to the Agricultural Commissioner for placement of 36 traps in citrus orchards throughout Placer County to detect the presence of the Asian Citrus Psyllid, a pest known to cause extreme injury to many of the agricultural crops grown in Placer County.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This revenue reimbursement is for an ongoing program.
