

SUBJECT: State funding for Pierce's Disease Enforcement Program July 1, 2010 through June 30, 2012.

ACTION REQUESTED

Adopt a resolution authorizing the Placer County Agricultural Commissioner/Sealer to sign contract #10-0343 with the California Department of Food and Agriculture allowing for reimbursement from the State in the amount of \$166,000 for reimbursement for Pierce's Disease Enforcement Program for fiscal years 2010 - 11 and 2011 - 12.

BACKGROUND

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

Under this contract, the County will be reimbursed up to a maximum of \$83,000 each fiscal year for participating in the State's Glassy-Winged Sharpshooter program for prevention and/or control of this insect pest, which transmits Pierce's Disease to grapevines. The State first began contracting with Placer County for this program during the 1999 - 2000 fiscal years.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This revenue reimbursement is for an ongoing program and has no impact on the General Fund.
