SUBJECT: Approve the Renewal of a Negotiated Blanket Purchase Order with Radiological Associates of Sacramento for Radiology Services in the Maximum Amount of \$280,000.00

ACTION REQUESTED

Approve the renewal of negotiated Blanket Purchase Order (BPO) No. BP017156 with Radiological Associates of Sacramento (RAS) for radiology services, and authorize the Purchasing Manager to sign the resulting blanket purchase order in the maximum amount of \$280,000.00.

BACKGROUND

The Health and Human Services' (HHS) Managed Care/Medically Indigent Adult (MIA) program requires an annual contract for diagnostic radiology services when these services cannot be performed at County medical clinics. These services are available at several RAS locations and various hospitals, which are in close proximity to the County's medical clinics. The prices charged for these services are based on the current Medi-Cal rates.

On September 22, 2009, your Board approved the award of BP017156 in the maximum amount of \$245,000.00 for the period of October 1, 2009 through September 30, 2010. HHS has requested to renew the existing BPO for another year in the maximum amount of \$280,000.00 based on the anticipated caseload of mandated Medical Care Services Program clients. RAS has agreed to renew this agreement for another year with no changes to contracted pricing structure, terms, or conditions.

County policy authorizes this renewal in accordance with Purchasing Policy Manual (PPM) Sections 1.3(a), which exempts professional services which involve extended analysis from competition, and PPM 7.2, which allows the award of blanket purchase orders for operational services based on geographical location relative to the County's sites of operations.

FISCAL IMPACT

HHS has requested a BPO in the maximum amount of \$280,000.00 to be effective from October 1, 2010, through September 30, 2011. Health & Human Services' Fiscal Impact Statement is attached.

The department has budgeted appropriately for the renewal of this \$280,000 Blanket Purchase Order (BPO) and funding for the first nine months is available in the Proposed FY2010-2011 Budget. The final three months of the BPO will be included in the FY2011-2012 Budget. The renewal amount is \$35,000 higher than the current BPO due to a growth in caseload of mandated Medical Care Services Program (MCSP) clients. Radiological services are provided to eligible recipients as part of the mandated MCSP which is funded 100 percent by the County General Fund.
