SUBJECT: Approve the Award of Competitive Bid No. 10006 to KME Fire Apparatus for One Type IV Fire Apparatus for Sunset West Fire in the Total Amount of \$216,112.14

ACTION REQUESTED

Approve the award of competitive Bid No. 10006 to KME Fire Apparatus of Ontario, CA for one type IV fire apparatus for Sunset West Fire in the total amount of \$216,112.14, and authorize the Purchasing Manager to sign the resulting purchase order (PO).

BACKGROUND

The Procurement Services Division developed Bid No. 10006 to solicit bids for one type IV fire apparatus to be used in supporting and responding to incidents in the Sunset Industrial Area (SIA) and surrounding areas. The Bid was sent to eighty vendors via E-Bid and posted on the County's website.

The bid evaluation considered pricing for one type IV fire apparatus. Local vendor preference, early payment discount, and compliance to specifications were also considered during the bid evaluation.

KME Fire Apparatus was the sole bidder. Based on their complete responsiveness to the bid requirements, staff recommends approval to award the resulting PO to the vendor for one 2011 Dodge/KME Type IV Brush Engine. Pricing for optional upgrades were provided by the vendor. The department opted to replace the 12 volt power scene lighting with 120 volt power and portable lighting.

FISCAL IMPACT

Staff recommends your Board's approval to award Bid No. 10006 to KME Fire Apparatus in the total amount of \$216,112.14. The Department's Fiscal Impact Statement is attached.
