**ACTION REQUESTED**

Approve the renewal of blanket purchase orders (BPOs) Orders with Andregg Geomatics of Auburn and Owen Psomas of Roseville for surveying services for the Department of Public Works (DPW), and authorize the Purchasing Manager to sign the resulting BPOs in the maximum aggregate amount of \$250,000.00.

**BACKGROUND**

On May 22, 2007, your Board approved a list of qualified surveying firms for Eastern Placer County that was developed from responses to Request for Qualifications No. 9643. The list was effective through May 22, 2010. Your Board also approved BPO awards to six of the firms on the list in the maximum aggregate amount of \$750,000. The Department of Public Works uses these firms for consulting services for various projects in Eastern Placer County throughout the year. On June 22, 2010, your Board approved a renewal of the qualified list, extending the expiration date through June 30, 2011. In accordance with the extended expiration date of the list, Public Works has requested to renew the six BPOs for the period of September 1, 2010 through June 30, 2011. Two BPO renewals were approved by your Board on August 24, 2010. Two firms have now agreed to renew, while responses from two remaining firms are pending. The BPOs to be renewed are:

BP016280	Andregg Geomatics Inc., Auburn	\$125,000.00
BP015054	Owen Psomas, Roseville	\$125,000.00

**FISCAL IMPACT**

Your Board's approval will result in the award of two BPOs in the maximum amount of \$125,000.00 each for a maximum aggregate amount of \$250,000.00. DPW's Fiscal Impact Statements are included as attachments to this Board Memo.
