SUBJECT: BLUE CANYON AIRPORT – RUNWAY RESTRIPING PROJECT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the submittal of an application for an Acquisition and Development Grant to Caltrans Division of Aeronautics for the runway restriping project at the Blue Canyon Airport, in the amount of \$9,000, and approve a Budget Revision to the Special Aviation budget.

BACKGROUND / SUMMARY

Placer County has been awarded a \$10,000 Acquisition & Development (A&D) Grant to restripe the Blue Canyon Airport runway and parking ramp. The \$10,000 requires a 10% local match, which will be taken out of the Airport's reserves. This grant was applied for under the 2010 California Aeronautics Program, and was approved on June 30, 2010. In order to receive the grant, it is required the Board of Supervisors adopt the attached Resolution 1) Authorizing filing an application for the funds 2) Authorizing accepting the allocation of the funds 3) Certifying the availability of the County's matching funds and cancelation of reserves for the required ten percent County match, and 4) Authorizing execution of the Grant Agreement.

ENVIRONMENTAL CLEARANCE

This project is Categorically Exempt from the provisions of CEQA as a Class 1 exemption, Section 15301 (c): "Maintenance of Existing Facilities".

FISCAL IMPACT

The County's required 10% local match (\$1,000) will be taken from the Special Aviation Budget reserves. The special aviation budget reserve has a current balance of \$17,011.
