BACKGROUND/COMMUNITY BENEFITS: In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked once again to help support the Placer County Japanese American Citizens League (JACL). The Placer County Japanese American Citizens League and Placer County have partnered to create a memorial at the new Bill Santucci Justice Center in Roseville to remember Americans of Japanese ancestry who served in WW II. Founded in 1929, the JACL is the oldest and largest civil rights organization in the United States whose ongoing mission is to secure and maintain the civil rights of Japanese Americans. The funds designated will help support the cost of an engraved brick to be set at the historic monument site in honor of Bill Santucci.
