Please know that the Placer County RCD Board of Directors, at their Tuesday, November 30, 2010 Board Meeting, considered the term expiration of three board seats. Under Section 9314, Division 9 of the Public Resources Code, these four year terms expired on Friday, November 26, 2010. However, please know that Section 9314 also states that "the expiration of the term of any director does not constitute a vacancy and the director shall hold office until his or her successor has qualified."

The Placer County RCD Board of Directors has unanimously approved that the following Board of Directors, Christine Johnson, David Funk and Steve Garcia, be considered by Board of Supervisors for appointment to another term. This next four year term is scheduled to expire on the last Friday of November, 2014.

At this time, the Placer County RCD Board of Directors respectfully requests that the Board of Supervisors accept their recommendation and move this action forward to their next scheduled Business Meeting in December.
