

**SUBJECT:** State Contract for Weed Management Area Program for Calendar Year 2011

### ACTION REQUESTED

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign a contract #10-0692 in the amount of \$16,489 for Placer Weed Management Area Projects with the California Department of Food and Agriculture allowing for reimbursement from the State for the Placer County weed eradication program.

### BACKGROUND

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs. This contract will reimburse costs associated with eradicating noxious, invasive weeds from Placer County before they become established on a widespread basis.

### ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

### FISCAL IMPACT

This contract provides for \$16,489 in reimbursements to the Placer County Agriculture Department for costs associated with the weed eradication program to offset the Placer County Agriculture Department's impact to the General Fund, including \$0 for Fiscal Year 2010/11, and \$16,489 for Fiscal Year 2011/12.
