**SUBJECT:** State Contract for Exotic Pest Detection Trapping/Emergency services for enforcing mandated programs for Fiscal Year 2010/2011.

**ACTION REQUESTED**

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #10-0194, Amendment 1 for Exotic Pest Detection Trapping/Emergency services with the State Department of Food and Agriculture allowing for reimbursement from the State for up to \$95,615 for enforcing mandated programs.

**BACKGROUND**

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs. Through enhanced funding received from the United States Department of Agriculture, CDFA has been able enhance Placer County's contract to better reflect actual program costs.

**ENVIRONMENTAL**

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

**FISCAL IMPACT**

This contract provides for \$69,513 in additional reimbursement beyond the original \$26, 102 to offset the Agriculture Department's impact to the General Fund. This amended contract amount accounts for the total expenses associated with the program.
