### ACTION REQUESTED

Adopt a resolution authorizing the Placer County Agricultural Commissioner/Sealer to sign a Memorandum of Understanding with the Citrus Research Board allowing for reimbursement for up to \$5,644 for costs associated with detection trapping of the Asian Citrus Psyllid in Placer County from March 1, 2011 through June 30, 2011.

### BACKGROUND

This contract will provide funding to the Agricultural Commissioner for placement of 36 traps in citrus orchards throughout Placer County to detect the presence of the Asian Citrus Psyllid, a pest known to cause extreme injury to many of the agricultural crops grown in Placer County.

### ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

### FISCAL IMPACT

This revenue reimbursement is for an ongoing program.
