**Subject:** Equipment Purchase for Sheriff's Evidence Division from CAL-ID Trust Fund

**Action Requested**

Approve a Budget Revision (Exhibit A) in the amount of \$7,200 from the CAL-ID Trust Fund to the Evidence Division Budget to purchase Crime-lite equipment, approve the early purchase, authorize the Purchasing Manager to execute all related documents and add the equipment to the Master Fixed Asset List (Exhibit B).

**Background**

In March 2011 your Board approved the purchase of a Crime-lite alternate light source used for processing evidence at crime scenes. The Evidence Division is extremely satisfied with the product and is requesting a second unit be purchased to have an additional resource available. The technology has now modernized to enhance the ability of the evidence team in locating trace DNA evidence when processing law enforcement crime scenes. In 2008 the Department of Justice (DOJ) conducted a comparison study of alternate light sources. The evaluation was published in the DOJ Bureau of Forensic Study Tieline™ Publication Volume 28 dated 2008. The conclusion of the study indicated that Crime-lites are the most effective device for crime scene analysis.

**Fiscal Impact**

Funds are available within the CAL-ID Trust for this purchase and will be transferred to the Sheriff's Evidence Division Budget. There is no impact to the General Fund.
