**SUBJECT:** FY 2011-12 Budget Workshop

**Action Requested**

Conduct a workshop on August 18 and 19 on the FY 2011-12 County Budget, including a fiscal overview, policy considerations, and presentations by departments on their operations. Provide direction to staff on preparation of the FY 2011-12 Final County Budget.

**Background**

The County Budget is the annual blueprint of the Board's priorities to balance available resources with the service needs of county residents. The County Budget is adopted in two phases: the Proposed Budget, adopted by the Board on June 7, is the County's interim spending plan effective July 1; the Final Budget is approved each September once final estimates of available resources have been determined. The County Budget must be adopted by October 2, 2011, under County Budget Act requirements.

As a bridge between the Proposed and Final Budgets, the County holds a budget workshop each August to update the revenue and expenditure estimates based on completion of the prior fiscal year, updated property tax and other revenues, and federal and state impacts. For FY 2011-12, the budget workshops will be held August 18 and 19, 2011. A tentative schedule is attached and provides a general guideline for the workshops. As such, the timing of individual items is subject to change.

Fiscal Year 2011-12 budget discussions began in February, and have included the following Board workshops to identify challenges within the county service delivery system including impacts related to the State Budget:
