Subject: Edward Byrne – Justice Assistance Program Grant

Action Requested

Accept the Justice Assistance Grant (JAG) in the amount of \$26,194 to partially offset the cost of one Probation Officer and approve the Budget Revision (Exhibit A) for the grant period from July 1, 2011 to June 30, 2014.

Background

On August 23, 2011 your Board approved the submittal of the JAG Grant for FY 2011-2012 funding. Our grant application and requested funding was approved. In 2010 we utilized our JAG funding for the Probation Officer assigned to the Special Investigations Unit (SIU) task force. The 2011 JAG grant funding will be used to continue to partially offset the costs of one Probation Officer. The Sheriff's Office is the lead agency for the grant. The Probation Officer working in SIU monitors high-risk situations for children in Placer County. This position works as a liaison between SIU, the Courts and other County departments. SIU works with school resource officers in Placer County to identify individuals who are selling drugs at local schools and to help determine what drugs are being sold. SIU contributes to the safety and well-being of Placer County residents and is part of the County's fight against drugs such as methamphetamines.

Fiscal Impact

Grant funds will be used to partially fund one Probation Officer assigned to SIU in the amount of \$26,194. There is no additional impact to the General Fund.
