BACKGROUND/COMMUNITY BENEFITS

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support Placer County Fair Association's *Kennedy Scholarship Pageant* in their efforts to renovate the Mahan Stage at the Placer County Fairgrounds. The Mahan Stage was built for the Miss Placer County Fair Pageant in 1937. Over the years many talented and remarkable women have won titles from Wee Miss to Miss Placer County, with the average age ranging from three to twenty-seven. In addition to being used for pageants, the Mahan Stage is used for talent shows, bands, and cultural and animal shows. Funding received will be used to defray the cost of repairs and renovations to the Mahan Stage dressing rooms, bathrooms, lighting fixtures, flooring, air conditioners, and the repainting of the stage and walkways to make them clean and enjoyable again.
