Subject: Approve Change Order No. 1 to Blanket Purchase Order #20099
With Bob Barker Inc.

Action Requested

Approve Change Order No. 1 to the Blanket Purchase Order (BPO) with Bob Barker Inc. for the purchase of inmate clothing, and authorize the Purchasing Manager to sign the resulting change order. This Change Order will increase the existing BPO amount of \$50,000 by \$17,000 for a revised amount of \$67,000 for the period of August 22, 2012 through September 30, 2013.

Background

The Placer County Sheriff's Office Corrections Division has maintained a BPO with Bob Barker Inc. since 1999 for the purchase of inmate clothing and supplies. With the addition of the AB-109 inmates, we are seeing greater destruction of clothing resulting in dramatically increased expenses. The Sheriff's Office is close to expending the existing BPO with Bob Barker Inc. and requires this increase to purchase necessary inmate clothing.

Fiscal Impact

Upon approval BPO #20099 will be increased to \$67,000. Funding is included in the FY 2013-14 Sheriff's Office Proposed Budget. There is no additional impact to the General Fund.


