**BACKGROUND**

The purpose of the Municipal Advisory Council is to advise the Board of Supervisors on matters of concern which relate to the area served by the Municipal Advisory Council. The Council shall advise the Board of Supervisors on matters specifically referred to it by the Board of Supervisors for review and recommendation. The Council shall adopt rules, regulations and procedures as are reasonable and appropriate for its activity, as are specifically approved by the Board of Supervisors. The council is composed of seven (7) members at-large, appointed by the Board of Supervisors, each serving two year terms. The council meets on the second Tuesday of each month at 6:00 p.m. in the Planning Commission Chambers, Community Development Resource Agency (CDRA) Building, 3091 County Center Drive, Auburn.




