



ACTION REQUESTED

1. Approve a Resolution commending Placer County Surveyor, Chuck Grant on 35 years of dedicated public service as an employee of the Placer County Community Development Resource Agency, Engineering and Surveying Division.

BACKGROUND

Chuck is retiring from the County of Placer Community Development/Resource Agency, Engineering and Surveying Division after 35 years of dedicated public service. Chuck was hired by Placer County in 1979 as an Engineering Aide in the Department of Public Works and was promoted 5 times between 1979 and 2002, and finally promoted to the position of County Surveyor in 2008;
