SUBJECT: Surplus Miscellaneous Servers

RECOMMENDATION

1. Declare miscellaneous server items listed on Attachment A as surplus and authorize their donation to Placer Hills Union School District, Weimar Hills School.

BACKGROUND

The Procurement Services Division has received a list of miscellaneous server equipment which the Department of Health and Human Services and Administrative Services - Information Technology (IT) Division have identified as having reached the end of their useful life. All the items listed have been removed from service by the County departments. County staff has reviewed the items listed for use on any existed or known upcoming projects and the equipment will not be useful for any of those projects. The servers listed are in operable condition and would provide newer technology and a significant amount of IT storage for an organization that is in need of this type of equipment. The IT staff of Weimar Hills School has expressed an interest in upgrading their current servers and has requested to utilize these servers.

The Procurement Services Division regularly makes items available to non-profit organizations within the Placer County community. Weimar Hills School has been a recipient of donated items such as binders, desks, office chairs, shelving, and computer monitors from the County's surplus warehouse. The school has greatly benefited from these donations which have provided a better learning environment for their students and faculty.

The items with a current remaining net book value exceeding \$2,500 are included for your review and approval. Your Board's approval is required to proceed with the donation of these surplus items.
