**ACTION REQUESTED**

Approve appropriation of \$3,500 in Revenue Sharing monies to *The Gathering Inn* to benefit their emergency housing program, as requested by Supervisor Weygandt (\$500) and Supervisor Holmes (\$3,000).

**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help fund *The Gathering Inn* for their Emergency Overnight Shelter expenses, and continue providing shelter on the weekends. Since *The Gathering Inn's* incorporation in September 2004, more than forty churches have united to provide emergency housing in Placer County. *The Gathering Inn* is the only emergency overnight shelter in South Placer County and provides a safe place to sleep, warm meals and social services to address the reasons for homelessness, and has helped over 200 people move into housing in the past two years. The faith-based program strives to foster a spirit of hope and dignity in the people it serves, and works to transition people out of homelessness by linking them to appropriate existing services, or by developing new ones. The funds designated will help provide physical, mental and spiritual restoration for homeless women, men and children and help offset the costs for alcohol and drug testing materials to ensure a clean and sober and safe shelter.
