BACKGROUND

The purpose of the Area 4 Agency on Aging Governing Board is to set agency policy and ensure that Area 4 Agency on Aging fulfills the mandates of the Older Americans Act.

For over 40 years, Area 4 Agency on Aging (A4AA) has helped older adults live as independently as they can, with safety and dignity. A4AA is a leader on aging issues, an advocate for all seniors in the area, and a major funding source for local organizations that provide services to seniors and caregivers. The A4AA Advisory Council participates and advises the Governing Board on regional, state and federal advocacy activities, and matters relating to the planning, delivery and monitoring of services.

The seventeen member Governing Board serves the seven counties of Nevada, Placer, Sacramento, Sierra, Sutter, Yolo and Yuba, and is composed of County Supervisors and their appointees. Sacramento County has 5 members, and each of the other 6 counties have 2 members, for a total of 17 members on the Board. Meetings are held the second Friday of the month at 10:00 a.m., and the location varies between the seven counties.
