Placer Arts is part of several event and initiative committees in the county and has been instrumental in fostering community concert series, art festivals, national arts exhibition, major multicultural celebrations and art education programs. Placer Arts presents professional performing arts and community theatrical performances in varying venues and sponsors presentation in more than thirty schools. The funds designated towards this organization will help defray operational costs.
