Subject: Amendment to the Contract between the Placer County Sheriff's Office and the Town of Loomis

Action Requested

Approve amendment No. 2 to the contract between the Placer County Sheriff's Office and the Town of Loomis for law enforcement services; authorize the Chair to sign and the Sheriff to execute the amendment. The net budgeted revenue from this amendment for FY 2014-15 is \$1,452,593, an increase of \$24,951 or 1.75%. The amendment term is from July 1, 2014 to June 30, 2015.

Background

The Placer County Sheriff's Office provides law enforcement services to the Town of Loomis. The law enforcement service costs are updated annually to reflect changes in salaries, benefits and services. This year's contract cost increased by \$24,951 or 1.75% for a total amendment amount of \$1,452,593.

Fiscal Impact

The estimated revenue for this amendment is included in the FY 2014-15 Sheriff's Office Proposed Budget. There is no additional fiscal impact to the General Fund.

AMENDMENT NO. 2

DESCRIPTION: Contract amendment between County of Placer, Office of the Sheriff-Coroner-Marshal and Town of Loomis updating the annual costs for FY 2014-2015

THIS AMENDMENT is made as of the 1st day of July, 2014, by and between the COUNTY OF PLACER, Office of the Sheriff-Coroner-Marshal, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and the TOWN OF LOOMIS, a municipal corporation, hereinafter referred to as "TOWN."

The TOWN is desirous of services and the COUNTY is willing to provide the services. **Section 5. PAYMENT FOR SERVICES** is modified to reflect the annual update of costs.

The cost of performing law enforcement for the year beginning July 1, 2014, and ending June 30, 2015 both dates inclusive, is agreed to the total amount of \$1,452,593 (ONE MILLION FOUR HUNDRED FIFTY-TWO THOUSAND FIVE HUNDRED AND NINETY-THREE DOLLARS). (See Exhibit A for calculations). This sum shall be paid in four quarterly installments of \$363,148 (THREE HUNDRED SIXTY-THREE THOUSAND ONE HUNDRED FORTY-EIGHT DOLLARS) to be paid on October 1, 2014, January 1, 2015, April 1, 2015, and June 30, 2015. The COUNTY will provide estimates adjusting salaries and Cost of Living to the TOWN each year for adoption effective July 1 with an amendment.
