SUBJECT: SOUTH YUBA RIVER BRIDGE PREVENTATIVE MAINTENANCE PROJECT

ACTION REQUESTED / RECOMMENDATION

1. Adopt a Resolution approving the project plans and specifications.
2. Authorize the Chair of the Board to sign the cover sheet of the project plans.
3. Authorize the Department of Public Works to advertise for bids for the South Yuba River Bridge Preventative Maintenance Project. There is no net County cost.

BACKGROUND / SUMMARY

The Department of Public Works is proposing to perform preventative maintenance on the existing bridge on Cisco Road over the South Fork of the Yuba River. The existing bridge was constructed in 1963 and is classified as structurally deficient because of the deteriorating condition of the deck. The proposed project will repair deteriorating areas of the deck, place a polyester concrete overlay, replace the joint seals, and improve other miscellaneous roadway appurtenances. The project is being funded with local County Road funds.

ENVIRONMENTAL

This project as defined in Section 15301 is Categorically Exempt and a Notice of Exemption was filed with the County Recorder's office on June 26, 2014.

FISCAL IMPACT

The total anticipated construction cost of the project \$300,000. The project is funded with local County Road funds and sufficient funds are included FY 2014-2015 fiscal year budget.




