BACKGROUND/COMMUNITY BENEFITS

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations for The Forgotten Soldier Program’s *111-Mile Motorcycle Run and Community Event* held on July 19, 2014. The Forgotten Soldier Program was founded five years ago to help Veterans who are having problems settling back into civilian life. The program provides Conventional and Complimentary Alternative Medicine (CAM) to any Veteran, or family member of a Veteran, in need at no cost to them. In 2012, approximately 160,000 sessions of Conventional and Complimentary Alternative Medicine services were provided to Veterans who were referred by the VA and the Wounded Warrior program.

The Motorcycle Run and Community event is the only major fundraiser held for The Forgotten Soldier Program. Funding received will help offset the cost of rental items, food and publicity for the event.
